



## 'G-D'S PHYSICS' (CUFT) NEW PHYSICS' PARADIGM: "MIRACLES" CAN HAPPEN!?

### ABSTRACT

Twenty-first Theoretical Physics is undergoing a profound "Paradigmatic-Shift" from the Old "Material-Causal" Paradigm underlying both Relativity Theory (RT) and Quantum Mechanics (QM) to the New "G-d's Physics" ("Computational Unified Field Theory", CUFT) Paradigm; The New 'G-d's Physics' Paradigm has been shown capable of resolving the apparent "theoretical inconsistency" between Relativity Theory (RT) and Quantum Mechanics (QM) and offer an alternative theoretical explanation for the accelerated expansion of the physical universe (which cannot be explained by the purely hypothetical and undetectable "dark-matter" and "dark-energy" concepts); Based on the discovery of a singular higher-ordered "Universal Computational/Consciousness Principle" (UCP) which *simultaneously computes* every exhaustive spatial pixel in the universe at the incredible rate of  $c^2/h = 1.36^{50} \text{ sec}^{-1}$  (!) this New 21<sup>st</sup> Century Physics Paradigm challenged and revised the basic "Material-Causal" assumption of the Old 20<sup>th</sup> century Old RT & QM Models: challenging the "Big-Bang" Model, Einstein's Equations, QM's assumed "collapse" of the target's probability wave function (following its assumed direct physical interaction with the corresponding subatomic probe element) etc. Instead, due to the New 'G-d's Physics' additional "Computational Invariance Principle" and "Universal Consciousness Reality" theoretical postulates indicating that only the "computationally invariant" UCP may be considered as "constant" and "real", whereas the "computationally variant" four basic physical features of "space", "energy", "mass" and "time" may only be regarded as "phenomenal" and "transient" – i.e., existing only "during" each consecutive "Universal Frame" (UF) being solely computed by the singular UCP, but "dissolving" back into this singular UCP "in-between" any two consecutive UF's frames; forces us to regard the whole existence of the entire physical universe (and its associated apparent "physical laws") as existing only "transiently" and "phenomenally" – as "manifestations" of this singular higher-ordered "Universal Computational/Consciousness Reality" (UCR)!

### 1. Introduction: Twenty-First Century's New 'G-d's Physics Paradigm

Twenty-first century Theoretical Physics has undergone a major "Paradigmatic-Shift" – i.e., from the Old 'Material-Causal' Paradigm underlying Relativity Theory (RT) & Quantum Mechanics (QM) towards the New 'G-d's Physics' ('Computational Unified Field Theory', CUFT) Paradigm which was shown capable of resolving the apparent "theoretical inconsistency" between RT & QM, and also offer an alternative satisfactory explanation for certain key Old 'Material-Causal' unexplained physical phenomena, including: the "dark-matter" and "dark-energy" (purely hypothetical) concepts whose empirical validation failed (thus far) but which is supposed to account for up to 95% of all of the mass and energy in the universe!?! As analyzed by Thomas Kuhn in his famous Book "On the Structure of Scientific Revolutions" (1962), Scientific investigation (and progress) within a given field shifts between phases of "Standard Science" in which the scientific inquiry within

a given discipline is based on an acceptable "Standard Paradigm" possessing certain assumptions, laws and stipulations, followed by an inevitable "Paradigmatic-Shift" phase in which the Old 'Standard Paradigm' doesn't suffice (any longer) to explain certain key (new) phenomenon, in addition to which there usually arise particular "theoretical inconsistencies" within the very foundations of the Old 'Standard Paradigm'... Indeed, this was the case when Einstein came along (e.g., prior to his 1905 "Annus-Mirabelus" and the 1915 ultimate empirical validation of one of the "critical predictions" of his New "Relativity Theory" Paradigm); The two basic "pillars" of the Old 'Standard Paradigm' of "Newtonian Mechanics" and Maxwell's "Electromagnetic Theory" seemed "contradictory" of each other and a key assumption within Newtonian Mechanics associated with the existence of the "ether" concept (which was supposed to pervade the entire physical universe) could not be found empirically despite numerous attempts to do so!?! This called for a "Paradigmatic-Shift" from the Standard

Newtonian-Maxwellian Paradigm to 20<sup>th</sup> century "Relativity Theory" and subsequently also Quantum Mechanics' Paradigm"...

Indeed, we've now reached an equivalent "pivotal-point" along the development of Science, wherein these two "pillars" of 20<sup>th</sup> century Theoretical Physics seem "contradictory" of each other, and the key empirical phenomenon of the accelerated expansion of the universe – cannot be account for by the purely hypothetical concepts of "dark-matter" and "dark-energy" which are supposed to account for up to 95% of all the mass and energy in the physical universe, but cannot be empirically detected! Now, as then, the Newly discovered "G-d's Physics" (Computational Unified Field Theory, CUFT) Paradigm is able to resolve this apparent "theoretical inconsistency" between RT & QM, embed the key elements of both Models within a singular "Universal Computational Formula" (UCF), and offer an alternative theoretical account for the accelerated expansion of the physical universe – while "discarding" the purely hypothetical concepts of "dark-matter" and "dark-energy" as "superfluous" (i.e., non-existent)!?

**Universal Computational Formula (UCF)**

wherein the singular higher-ordered UCP – represented by the Hebrew letter "Yud" ("י") simultaneously computes all exhaustive spatial pixels in the universe comprising each consecutive Universal Frame/s (UF's) which already exist in a "potential-from" within the UCP's "Supra Spatial-Temporal Reservoir" of all "past", "present" and multiple possible "future/s" UF's (represented by the Hebrew letters from "ך through "נ " to "ן") depending on the Moral Choice of each Individual Human Consciousness – as computing and integrating these four basic physical features of "space" and "energy", "mass" and "time", at the incredible rate of: "c<sup>2</sup>/h" = 1.36<sup>-50</sup> sec<sup>-1</sup>!

Succinctly stated, this New 'G-d's Physics' Paradigm is based on the discovery of a new singular, higher-ordered "Universal Computational/Consciousness Principle" (UCP) which simultaneously computes every exhaustive spatial pixel in the universe at the incredible rate of "c<sup>2</sup>/h" = 1.36<sup>-50</sup> sec<sup>-1</sup>!, thereby producing a series of "Universal Frames" (UF's) depicting the entire universe (at every such minimal "time-point")! According to this New 'G-d's Physics' (CUFT) Paradigm, the whole entire physical universe "dissolves" back into the singularity of this singular, higher-ordered UCP "in-between" any two consecutive UF's frames...

One of the key differences between this New 'G-d's Physics' (CUFT) Paradigm and the Old 'Material-Causal' Paradigm is its insistence upon the "simultaneity" of the UCP's computation of each exhaustive spatial pixel, e.g., for each consecutive UF's frame/s, which negates the very possibility of the existence of any direct physical interaction/s between any two (or more) exhaustive spatial pixels existing either in the same- or different-UF's frames! This is because, if indeed all exhaustive spatial pixels comprising the entire physical universe are *simultaneously* computed by the (singular, higher-ordered) UCP for each consecutive UF's frame/s then there cannot exist any such direct physical interactions taking place at any (single or multiple) UF's frame/s! Likewise, since according to his New 'G-d's Physics' Paradigm the entire physical universe "dissolves" "in-between" any two consecutive UF's frames, therefore there cannot also exist any such physical interactions, e.g., between any two (or more) exhaustive spatial pixels existing across different UF's frame/s! Nor can there be any "transference" of any "material" entity or effect across any two consecutive UF's frame/s! This entirely new singular higher-ordered conception of the physical universe as being continuously computed, "dissolved", re-computed and evolved by the singular, higher-ordered UCP has led to the negation- and revision of some of the most basic 'Material-Causal' assumptions underlying both RT & QM: Thus, for instance, RT's assumed 'Big-Bang' nuclear explosion which supposedly "caused" the creation of all suns' galaxies, planets, 'mass' and 'energy' etc. in the universe was challenged and negated by this New 'G-d's Physics (CUFT) Paradigm, due to the principle impossibility of the existence of any such direct physical interaction/s between any two (or more) exhaustive spatial pixels in the first, second, third etc. UF's frames, comprising the 'Big-Bang' Model! Instead, the New 'G-d's Physics' Paradigm stipulates that for each consecutive UF's frame/s, the singular, higher-ordered UCP simultaneously computes the four basic physical features of 'space' and 'energy', 'mass' and 'time' for each exhaustive spatial pixel comprising the entire physical universe – thereby in effect stating that the origination- "dissolution"- re-creation- and evolution of each exhaustive spatial pixel comprising the entire physical universe is an ongoing, continuous process produced solely by the singular higher-ordered UCP!

Likewise, the New 'G-d's Physics' Paradigm negated the basic 'Material-Causal' assumption underlying General Relativity's "Einstein's Equations", e.g., assuming that it is the direct physical interactions between certain "massive objects" and "Space-Time", which "causes" the "curvature" of this 'Space-Time', and conversely that it is this 'curved Space-time' which "causes" (or determines) the "travelling pathways" of these 'massive objects' (or other less massive objects); This basic Old 'Material-Causal' Paradigm's assumption is being negated and rejected by 'G-d's Physics' New Paradigm's insistence upon the simultaneity of the UCP computation of all exhaustive spatial pixels in the universe (for each

consecutive UF's frame/s) and the complete "dissolution" of the entire physical universe "in-between" any two consecutive UF's frames! Therefore, there cannot exist any such direct physical interactions between any two (or more) exhaustive spatial pixels comprising the entire physical universe – hence negating the possibility of certain 'massive objects' "causing" the 'curvature of Space-Time', and conversely of such 'curved Space-Time' "causing" the particular 'travelling pathways' of these 'massive objects' (and other less massive objects)! As a matter of fact, the entire evolution of the physical universe – as originated by a (hypothetical) initial 'Big-Bang' nuclear explosion, subsequently evolved by Einstein's Equations – e.g., including the purely hypothetical "dark-matter" or "dark-energy" entities "causing" the empirically observe accelerated expansion of the universe etc. – is completely negated and rejected by the New 'G-d's Physics' Paradigm's insistence upon the continuous, simultaneous computation of the singular, higher-ordered UCP of each and every exhaustive spatial pixel in the universe for each consecutive UF's frame/s, and the complete "dissolution" of all of these universe's exhaustive spatial pixels "in-between" any two consecutive UF's frame/s!

In much the same manner, the New 'G-d's Physics' Paradigm was shown to negate the Old 'Material-Causal' Paradigm's assumption underlying Quantum Mechanics: According to QM 'Material-Causal' assumption, any given subatomic target possesses a "probability wave function" prior to its subatomic measurement brought about through its direct physical interaction with another corresponding subatomic 'probe' element – which then "causes" the "collapse" of this 'probability wave function's multifarious values into a singular (complimentary 'space-energy', 'mass-time') value. But, as we've already seen, since the New 'G-d's Physics' Paradigm postulates that the singular higher-ordered UCP simultaneously computes all exhaustive spatial pixels comprising the entire physical universe (e.g., for each consecutive UF's frame/s), therefore the New 'G-d's Physics' negates the very possibility of any such direct physical interaction between any two such subatomic 'probe' and 'target' elements (i.e., at any single or multiple UF's frames); Likewise, QM's basic assumption regarding the dual nature of any such subatomic 'target' element – which can exist either as a 'particle' or as a 'wave' has been considerably revised by the New 'G-d's Physics' Paradigm based on its discover of the singular higher-ordered UCP; This is because this single, higher-ordered UCP is postulated to simultaneously all "exhaustive" spatial pixels comprising any given consecutive UF's frame – including: all 'single spatial-temporal' "particle" values and 'multiple spatial-temporal' "wave" values, as embedded within the exhaustive computational framework of the consecutive UF's frames (comprising all exhaustive spatial pixels of the entire physical universe for each 'minimal time point').

## 2. The UCP's Singular Higher-Ordered "Universal Consciousness Reality"

Now, after having glimpsed the significance of "G-d's Physics" New 21<sup>st</sup> century Paradigm, we are ready to analyze and discuss some of the unique (new) features of this novel 'G-d's Physics' (CUFT) theoretical postulates; Thus, for instance, the new "A-Causal Computation" theoretical postulate asserts that since the singular higher-ordered UCP simultaneously computes all exhaustive spatial pixels in the universe, e.g., for each consecutive UF's frame/s, and since the entire universe "dissolves" in-between any two such consecutive UF's frames, therefore the other "Computational Invariance Principle" postulate suggests that only the "computationally-invariant" UCP, which exist constantly and continuously both "during" its computation of each consecutive UF's frame, and also exists (singularly) "in-between" any two consecutive UF's frames (without the presence of any physical universe) may be regarded as "real", whereas the entire physical universe – which exists only "during" each consecutive UF's frame (as totally contingent upon the UCP's simultaneous computation of all exhaustive spatial pixels) but ceases to exist and "dissolves" back into the singularity of this UCP "in-between" any two consecutive UF's frames may only be regarded as "transient" and "phenomenal" (termed: "computationally-variant")! Indeed, these two new UCP's 'A-Causal Computation' and "Computational Invariance Principle" theoretical postulates completely alter our basic understanding (and appreciation) of the true nature of the physical universe – as representing only a "transient", "phenomenal" manifestation of the singular Universal Computational/Consciousness Principle (UCP)! If the entire physical universe exists only "transiently" and "phenomenally" – "during" each consecutive UF's frame/s, but "dissolves" back into the singularity of the UCP "in-between" each two consecutive UF's frames, then we cannot regard it (any longer) as a "real-independent" physical reality that exists "in and of itself", but only as a "manifestation" of the singular "computationally-invariant" "Universal Computational/Consciousness Principle" (UCP), which exists "uniformly" and "constantly" – both "during" its (extremely rapid: " $c^2/h = 1.36 \cdot 10^{50}$  sec<sup>-1</sup>!) computation of each consecutive UF's frame/s, and also solely exists (without the presence of any physical universe "in-between" any two consecutive UF's frames; then we must reach the inevitable theoretical conclusion wherein only this singular 'computationally-invariant' UCP may be regarded as "real" and "constant", whereas the entire physical universe is seen only as a "transient", "phenomenal" manifestation of this singular higher-ordered "Universal Consciousness Reality"!

Indeed, one of the most advanced theoretical postulates of this New 'G-d's Physics' (CUFT) Paradigm is the "Universal Consciousness Reality", i.e., which suggest that since only this singular higher-ordered 'Universal Computational/Consciousness Principle' (UCP) exists 'uniformly' and 'continuously' – both "during" its

(simultaneous) computation of each consecutive UF's frame/s and also "in-between" each two such consecutive UF's frames, whereas the entire physical universe is seen as existing only "during" these consecutive UF's frames, but completely "dissolve" back into the singularity of the UCP 'in-between' any two such consecutive UF's frames; therefore, in truth, there exists only one "solid", "continuous" "unchangeable" reality which is termed: the "Universal Consciousness Reality", which exists solely (without the presence of the physical universe) 'in-between' any two UF's frames, and which "manifests" as the physical universe "during" each consecutive UF's frame/s! The realization of the singularity and "oneness" of all creation, of every exhaustive spatial pixel in the universe – with this singular "Universal Consciousness Reality" and the emphasis on this singular "Universal Consciousness Reality" being identified with the "Universal Consciousness Principle" arises (among other considerations) particularly from the abovementioned "Computational Invariance Principle"! This is because when we realize that according to this 'Computational Invariance Principle' there cannot "pass" any "material-entity" or any "material-effect" from one (given) 'Universal Frame' to any other consecutive UF's frames – due to the complete "dissolution" of all of the universe's exhaustive spatial pixels "in-between" any two consecutive UF's frame/s, then we must accept the fact that the entire physical universe is "retained" in a "potential-form", i.e., as a "memory" within this singular higher-ordered "Universal Consciousness Reality" 'in-between' any two consecutive UF's frame/s!?

The entire physical universe is undergoing a "dramatic" metamorphosis from being considered as an "objective-independent" physical or "material" entity to being realized as only an "active-memory" or "active manifestation" of the only "real", "continuous" and "constant" "Universal Consciousness Reality"! Since all of the exhaustive spatial pixels comprising the entire physical universe – "dissolve" 'in-between' any two consecutive UF's frames back into the singularity of the Universal Consciousness Reality, so that no "material-entity" or no "material-effect" "pass" across any two such consecutive UF's frames, therefore the only manner in which any "atom", "plant" or "even "Human-Being" can continue to "exist" and even "evolve" across a given series of UF's frames – is only based on the "Conscious-Memory" of this singular higher-ordered "Universal Consciousness Reality"! This singular, higher-ordered "Universal Consciousness Reality" may be likened to what's happening in Human-Being's "Dream State" of Human Consciousness: we can see that even though, during the 'Dream-State' everything in the 'Dream' seems very "real" and "physical", when we "awaken" from this 'Dream State' into the 'Waking State' we realize that every "exhaustive spatial pixel" comprising the entire 'Dream State' "universe" – was in truth, only a manifestation of the Human Consciousness of that individual! To use the previously mentioned "Cinematic-Film Metaphor" which likens the singular "Universal

Computational/Consciousness Principle" (UCP) continuous production of the entire physical universe to the dynamics of a 'Cinematic-Film'; it was illustrated in this 'Cinematic-Film Metaphor' that in the same manner in which we could calculate the "energy" ("velocity") of any given object in the film based on the degree of its "displacement" across a given series of 'Cinematic-Film Frames', so does the "Universal Computational/Consciousness Principle" compute each and every exhaustive spatial pixel in the physical universe based on its two (out of three) Computational Dimensions, e.g., "Framework" ('frame' or 'object') and "Consistency" ('consistent' or 'inconsistent') four possible combinations which yield the four basic physical features of 'space' and 'energy', or 'mass' and 'time'! In that 'Cinematic-Film Metaphor' (elaborated and delineated extensively in multiple previous peer-reviewed published scientific articles), it also became apparent that 'in-between' any two consecutive 'Cinematic-Film' Frames the "reality" of all of the exhaustive spatial pixels comprising the entire 'Film-Universe' "dissolved" or was "retained" only within the Film's stored "dvd's bank" of all "past", "present" and "future" 'Film-Frames'! Indeed, we may say that the only "reality" of the "Film's Universe" – whether it be "during" the presentation of each consecutive 'Film-Frame' (e.g., considered as the "present" state in the 'Film's Universe') or whether it be "in-between" any two consecutive UF's frame/s in which there only exists the "pure-light" and the 'Film-Frames' are all "stored" within the "dvd's bank" of "past", "present" or "future" frames, at all "times" the entire "Film's Universe" exists only as part of the dvd's bank of frames! This was shown to be somewhat equivalent to the "nature" and "dynamics" of the singular higher-ordered 'Universal Consciousness Principle's production- "dissolution"- re-computation- and evolution- of each and every exhaustive spatial pixel/s comprising the entire physical universe! It was indicated that this singular higher-ordered "Universal Consciousness Principle" (UCP) or "Universal Consciousness Reality" (UCR, as discussed also above) possesses a higher-ordered "Multi Spatial-Temporal Reservoir" which comprises all "past", "present" or multiple possible "future/s" 'Universal-Frames' (UF's) of the entire physical universe!

Nevertheless, there exist a few significant changes between this 'Cinematic-Film Metaphor' and the UCP or UCR's production- dissolution- re-computation- and evolution- of the entire physical universe to its "metaphoric" 'Cinematic-Film' progression; as stated previously, these differences include: the fact that unlike the 'Cinematic-Film' Metaphor in which every object that exists in one 'Film-Frame' – is likely to be presented (and "exist") in the subsequent 'Film-Frame', regardless of its "mass" value, within the UCP's sole extremely rapid production of the entire physical universe, relatively "more massive" objects will be presented at a greater number of 'Universal-Frames' than relatively 'less-massive' objects! This was, in fact, one of the unique "critical-predictions" of the New 'G-d's Physics' (CUFT)

Paradigm which differentiates it from the corresponding predictions of the Old 'Material-Causal' Paradigm! This is because according to the New 'G-d's Physics' Paradigm the "mass" of any given relativistic object or subatomic particle entirely depends on the UCP's computation of that "object-consistent" presentations across a given series of Universal-Frames (UF's), so that a relatively 'more-massive' object would be presented across a greater number of UF's frames than a relatively 'less-massive' object! This unique "critical-prediction" of the New 'G-d's Physics' Paradigm can be tested in subatomic Accelerators – by comparing the presence of a relatively 'less-massive' particles such as the "electron" across a given number of such 'Universal Frames' to the equivalent "Fine-Temporal Measurement" of the presence of 'more-massive' particles such as the "Muon"(e.g., with a "technological constraint" imposed on such extremely rapid measurement for which a "sampling" procedure was suggested)! Indeed, based on a previously published article which predicted that the relatively 'more massive' 'Muon' particle would be measured across a greater number of UF's than the relatively 'less-massive' electron particle (and that the presentation of the 'more massive' Muon particle should be proportionally more "spatially-consistent" and yield "accurate" subatomic measurements according to the New 'G-d's Physics' CUFT UCP's computational definition of "mass), this was shown to be corroborated empirically through the findings associated with the "Proton-Radius Puzzle" (Pohl, 2010) Nevertheless, recent published articles called the International Physicists/Astronomers/Cosmologists community to carry out several specific experiments and observations that could test some of this New 'G-d's Physics' unique "critical-predictions" of which this subatomic Accelerator's measurement of the greater number of times that the more massive 'Muon' particle would be detected across a series of (sampled) UF's frames, than the less massive electron particle!

Perhaps more significantly, another difference between the abovementioned 'Cinematic-Film Metaphor' and the Universal Consciousness Principle (UCP or UCR) relates to the existence of "multiple possible future/s" – and (most recently discovered) also "multiple possible past/s"! According to the New 'G-d's Physics' (CUFT) Paradigm, the UCP's higher-ordered "Multi Spatial-Temporal Reservoir" comprises all of the (multiple possible) "past/s", "present" and (multiple possible) "future/s" UF's frames – for each Individual Human Consciousness, based on its Moral-Choice/s made at each given moment in time! This was associated with 'G-d's Physics' discovery of the "Dynamic-Equilibrium" Moral Principle, which postulates that the singular higher-ordered UCP (or UCR) possesses an intrinsic propensity to strive towards a "Moral-Balance", towards a State of "Harmony (and indeed "Moral-Perfection", as will be further discussed later on in this article), which stems from the "Inseparability" of all Individual Human Consciousness from this singular higher-ordered

"Universal Consciousness Reality"! Another "Trampoline-Metaphor" was utilized to try and elucidate the "nature" and "dynamics" of this "Unitary", "Moral-Balancing" operation of the UCR: imagine a "Trampoline" delicate 'Membrane' – to which is attached a "Metal-Bar" connecting two "Individual Points" along this 'Membrane'; now imagine a situation in which one of these 'Individual Points' opts to "inflict pain/suffering" upon the other point, e.g., by "pushing" this 'Metal-Bar' against the other point... Obviously, such a "violent (immoral) action" would trigger an "opposite-equal" violent action wherein that same 'Metal-Bar' would cause the first "inflicting-pain" point to "experience" the same degree of "pain/suffering" that it imparted unto the 'other point'! This 'Trampoline Metaphor' would be likened to UCP's "Dynamic-Equilibrium" Moral Principle which states that since all of the apparently "separate" "Individual Human Consciousness", in truth, comprise integral parts of this singular (unitary) 'Universal Consciousness Reality' (UCR) therefore the UCR possesses an intrinsic propensity towards "balancing" and harmonizing" all of its constituent 'Individual Human Consciousness' elements! This implies that just as in the 'Trampoline-Metaphor', any case in which one 'Individual Human Consciousness' makes a "Moral-Decision" to "inflict-pain" or "suffering" upon another Individual Human Consciousness this "triggers" a computation by the UCR to "balance" this transient "moral-imbalance" by producing a situation in which that Individual Human Consciousness (one "point" along the UCR's "Membrane") which inflicted the 'pain/'suffering' upon the second 'Individual Human Consciousness' (a 'second' point along the UCR's 'Membrane') – would have to experience an "equivalent" (degree and intensity) of the same kind of 'pain/'suffering' that it inflicted upon the other Individual Human Consciousness...

As mentioned above, this creates the possibility of "multiple possible future/s" – and by extension also "multiple possible past/s", based on any (of the almost eight Billion!) Individual Human Consciousness selection of any given "Moral-Choice/s" at any given point in time!? To give an illustrative example of this UCR's selection of one of multiple possible "future/s" for each Individual Human Consciousness, imagine a scenario in which a high-level CEO is on its way to an important "annual-meeting" with the "Board of Directors" – in which it knows he will be offered a significant "bonus" for his successful achievements during that consuming year; But, as he speeds in his nice (brand-new "Lamborghini") car encounters an "unexpected" slow-down in traffic, as he notices an 'injured-driver' in his "crashed-car", (G-d-forbid) "bleeding"... our CEO quickly considers the "Moral-Choice" at hand: should he stop and "rescue" this "injured bleeding driver" in his (brand-new) Lamborghini car and potentially "miss" his important annual meeting – or should he make (an "unlawful") "U-Turn" and "pretend" that he "didn't see" this "injured bleeding driver" – and let somebody else "take-care" of

this "problem"? Well, the idea is that for each of this CEO's potential 'Moral-Choice/s' there is a corresponding selection of one of "multiple possible future/s"! If he selects the "right Moral-Choice" – and evacuates this 'injured-bleeding driver' on his nice (luxurious leather) seats and "potentially misses" that important "annual-meeting", then by selecting this "noble" Moral-Act, this CEO Individual Human Consciousness has "de-facto" selected an equivalent "Moral-future" for himself! The UCR registers and "remembers", calculates and produces precisely such a singular "future" for that CEO – in which he will also "need assistance" in some "critical situation" and would be "rescued" by some other 'Individual Human Consciousness', e.g., likely that same "injured-driver" Individual Human Consciousness! Conversely, if that important CEO opted to make an "Immoral-Choice", making an (illegal) U-Turn and rushed to that important "annual-Board meeting" – then that poor 'Moral-Choice' would also "trigger" a "proportionate" UCR computation of another possible "future" – which would force this CEO to "experience" an "equivalent-situation" in which he will be "injured" and need urgent assistance – 'G-d forbid', "suffering" the same kind of pain/suffering that it "inflicted" (or was at least was involved in)... It is important to note that this UCR's singular higher ordered 'Dynamic-Equilibrium' Moral Principle "balancing" of any "Moral/Immoral" Choice/s made by any Individual Human Consciousness – is propelled by the UCR's intrinsic "Good-Will" and "Free-Will" propensities which "strives" to bring the entire physical universe towards an Ultimate Goal State of "Geula", e.g., a State of utter "Moral-Perfection", in which the "Oneness", "Magnanimity", Infinite "Wisdom", "Peace", "Harmony" of this singular higher Ordered UCR will be manifest in- and throughout the entire physical universe!

### 3. The Moral "Dynamic-Equilibrium" Principle, Multiple "Future/s" and "Past/s", "Miracle/s" & the UCR's Ultimate "Geula" Goal!

So, we reach the inevitable conclusion wherein the physical universe – does not exist as an "objective-independent" reality, but rather as a manifestation of the singular higher-ordered "Universal Consciousness Reality" which exists both "during" each consecutive UF's frame/s (e.g., as solely computing each exhaustive spatial pixel's four basic physical features of 'space', 'time', 'energy' and 'mass' comprising the entire physical universe), as well solely exists (without the presence of any physical universe) "in-between" any two such consecutive UF's frame/s! We understood therefore (e.g., through the Cinematic-Film Metaphor) that alike the (somewhat equivalent) 'Cinematic-Film' dynamics, that the appearance of the "physical universe" in the film – is realized to exist only "transiently" and "phenomenally" "during" each consecutive 'film-frame', but ceases to exist 'in-between' any two consecutive frames; But, unlike this 'Cinematic-Film' Metaphor, in the case of the Universal Computational/Consciousness Reality's (UCR) extremely rapid production (" $c^2/h$ "= $1.36^{50}$  sec') of the

'Universal-Frames', each exhaustive spatial pixel in the universe actually "dissolves" back into the singularity of this UCR – and comprises an integral part of It! Unlike the 'Cinematic-Film Metaphor', in which the various "past", "present" and "future" film-frames are simply "stored" within the film's "dvd" storage, but they are not integral parts of the "Film's Director's Consciousness" – and hence cannot undergo any "interactive-dynamic change" that relates to any "remorse" or any "changes" taking place in the Director's Consciousness; to revert back to the earlier mentioned UCR's "Multi-Spatial-Temporal Reservoir" which contains all "multiple possible past/s", "present" and all "multiple possible future/s" the basic assumption of the New 'G-d's Physics' Model is that based on the "Dynamic-Equilibrium" Moral Principle, at each point in time, the UCR (or UCP) computes – and selects one of multiple possible "future/s" for each Individual Human Consciousness based on the Moral Choice/s. Similarly, recently 'G-d's Physics' New Paradigm discovered that through a conscious process of "teshuva" (based on the Jewish Tradition concept) – i.e., including a sense of "remorse", a strong conscious decision to not repeat any "wrong-doing", and a willingness to "ask for forgiveness", e.g., from the other person upon which this Individual Consciousness inflicted "pain" or "suffering", as well as from this singular higher-ordered UCR – for "violating" it's (intrinsic) "Dynamic-Equilibrium" Moral Principle; based on this "teshuva" conscious process, it is possible for any such given Individual Human Consciousness to alter its previous "past" – into an alternate (new) "past" which conforms with the newly-made conscious "Moral-Choice" brought about by this "teshuva" process! This means that unlike in the regular "Cinematic-Film" Metaphor, in which all of the given 'film-frames' constituting a given film are "fixed" and remain constant (and singular) for all "past", "present" and "future" film-frames, in the UCR's computation and depiction of the physical universe, there exists multiple possible "future/s" – based on the "present" Universal Frame's "Moral/Immoral Choice" determined by any given Individual Human Consciousness, which "selects" one of multiple possible "future/s", and which can also potentially alter and change that Individual Human Consciousness' "past" (e.g., to the extent that that Individual Human Consciousness makes a conscious "teshuva" Moral Good Choice which then alters that Individual Human Consciousness past "wrong-doing/s")!

Indeed, when we come to consider the wider scope of the UCR's singular production- sustenance, "dissolution" and evolution of each and every exhaustive spatial pixel comprising the entire physical universe (for each consecutive Universal Frame's minimal time-point), we realize that this UCR's production and evolution of the entire physical universe – from its very first "inception" throughout its evolution and leading up to its ultimate Goal of "Moral, Spiritual and Physical Perfection" termed: "Geula" (in Jewish Tradition) is "driven" by this singular higher-ordered UCR's "Ten Laws of

Hierarchical Manifestation"(previously discussed); These "Ten-Laws of Hierarchical Manifestation" posit that this singular higher-ordered UCR possesses a basic fundamental "Good-Will" propensity to "Do-Good", "Give-Life" and advance the whole of the physical universe towards an ever growing "awareness" and "manifestation" of this singular higher-ordered UCR's production, manifestation and evolution of the universe! Hence, as discussed previously, the evolution of both the "Physical Universe" and of its "Biological-Forms" – was not created based on a "random" and "meaningless" initial "Big-Bang" nuclear explosion, and accompanying "random-mutation" based (Darwin's) Evolutionary "Natural Selection" Process!? Instead, according to the New 'G-d's Physics' Paradigm, the whole purpose of the constant and continuous production- "dissolution" re-production and evolution of the entire physical universe is directed towards the UCR's singular "Geula" Ultimate Goal of "Moral", "Spiritual" & "Physical" Perfection; hence, the UCR's portrayal of the creation of the various galaxies – at the apex of which stands our own "Earth" Planet, upon which the UCR's evolution of "inanimate", "animate": plants, animals – and leading up to the appearance of Human-Beings, and then up to appearance of the fully "Expanded" form of "Individual Human Consciousness" (in which the Individual Human Consciousness is completely "identified" with the "Universal Consciousness" enabling it to "know" and "affect" different "past", "present" and "future/s" Universal Frames potentialities as well as transcend the strict limitations of "space" and "time")... Ultimately this singular higher-ordered UCR strives to manifest a 'Morally Perfected' "Geula" State, in which the singularity of this UCR's production and manifestation as the physical universe will be realized, and consequently, a "Perfected State" of our world (and of the entire physical universe) will be brought about – since all Human-Beings will realize their utter "Oneness" and "Unity" with this singular higher-ordered UCR – and with each other; and hence there could not exist any "inharmonious" Immoral-Actions, rather leading to a State of Complete Peace and Harmony, "Reverence" and "Gratitude" towards that singular higher-ordered UCR! In fact, one of the "surprising" and "exciting" facets of this newly discovered Ultimate "Geula" State of the universe is the (previously delineated) "Reversed-Time Goal Hypothesis", which posits that from the UCR's initial production of the universe (e.g., within its initial 'Universal Frames') throughout its long-history of the universe's and our world's constant "progression" towards this Ultimate UCR's Goal of a "Morally-Perfected Geula" State, the hypothesis is that this whole creation and evolution of the entire physical universe is solely and singularly directed and computed from that "Geula" " Ultimate Future State" towards all possible "past/s", "present/s" and "future/s" states of the universe! In other words, this ("fascinating" and "amazing") "Reversed-Time Goal Hypothesis" suggests that the entire (ongoing and continuous) production- "dissolution"- re-production and evolution- of all of the

physical universe's "Universal Frames" (and of every constituting 'exhaustive spatial-pixel comprising it) is all computed (and directed) from the singular higher-ordered UCR's "computational perspective" of reaching it's Ultimate "Geula-State" of "Moral", "Spiritual" and "Physical" "Perfection"! To give a familiar metaphor – we could somewhat equate the UCR's constant and singular striving towards that Ultimate "Geula" State to our car's familiar "Waze" Global-Navigation System, which allows us to set a "goal destination" and then calculates and directs all of our driving towards reaching that single ultimate "destination-goal"! It is suggested that in much the same manner as the "Waze" software allows us to "set" an "ultimate navigation goal" – and then directs all of our driving to reach that 'ultimate driving goal', so (in some manners) the UCR has set a singular Ultimate "Geula" Goal of manifesting "Total Peace, Harmony and Recognition of the Singular Unity & Existence of the UCR" (manifesting as this physical universe), and has been constantly "directing" all of our human history, the evolution of the forms from inanimate through animate: animals, plants and Human-Beings (leading up to the "Expanded" form of Individual Human Consciousness) towards that Ultimate "Geula" State... Viewed in this new "light" we understand that nothing happens "by chance", that every billionth of a billionth of every second (e.g., at the UCR's incredible rate of " $c^2/h$ " =  $1.36^{50}$  sec!) this singular higher-ordered UCR computes and directs the entire physical universe's evolution towards that "Perfected Geula" State, including the UCR's constant and continuous computation at each consecutive UF's frame/s the precise "Dynamic-Equilibrium" Moral Principle's calculation of the appropriate UF's frame/s configuration for each Individual Human Consciousness its "balancing" Moral-based selection of one of multiple possible "future/s" (as well as consequential "past/s" based on each Individual Human Being's potential for making a conscious moral "teshuva")...

It is obviously "inconceivable" for our limited human Intelligence (e.g., or even for our most sophisticated "Super-Computers") to even "fathom" the possibility of even getting "close" to comprehending the "complexity" and "infinity" of this singular higher-ordered UCR's computation (and selection) for each Individual Human Consciousness its appropriate single actual "future" (e.g., from an almost infinite possible array of multifarious possible future/s), which has to be computed simultaneously for the almost eight billion Human-Beings on the planet today, as well as take into consideration all of the abovementioned "Dynamic-Equilibrium" Moral Principle's UCRs computation of the "coupling" of each two given Individual Human Consciousness' – i.e., in terms of their "moral-balancing" such that in any given moment in time in which one Individual Human Consciousness made a given 'Moral/Immoral Choice' towards any other particular Individual Human Consciousness, then this 'Moral/Immoral Choice' necessarily "triggers" the UCR's

(unfathomably) complex computation of a particular selected (and "configured") particular UF's frame/s single "future" that can "rectify" and "morally-balance" these two Individual Human Consciousness' restoration of "moral-balance" etc.' (which also includes the possibility of "rectifying" and potentially altering the multiple possible "future/s" and "past/s" – based on a moral choice of "teshuva" by any of these Individual Human Consciousness)... We have to "multiply" this incredibly complex process of computation for the almost eight Billion Individual Human Consciousness – and also take into consideration that this Individual Human Consciousness UCR's Moral 'Dynamic-Equilibrium' Principle computation is embedded within the broader UCR's "Reversed-Time Goal Hypothesis" striving towards the Ultimate "Geula State" of "Moral, Spiritual and Physical Perfection" (e.g., which also includes the possibility of the "Abolishing of Death", as previously described); and to take into consideration that this singular UCR has to simultaneously "compute", "remember", "dissolve" and "evolve" (towards that singular Ultimate "Geula Perfected State") every exhaustive spatial pixel in the universe for each consecutive UF's frame/s at the incredible rate of " $c^2/h = 1.36^{50}$  sec'! across the whole entire universe!

Therefore, we reach the inevitable conclusion wherein nothing in the universe happens "by-chance" – not the Old "Material-Causal" Model's assumption of the "randomly" occurring "Big-Bang" nuclear explosion (assumed to have created the physical universe), nor the "random-genetic mutations" constituting Darwin's assumed "Natural Selection Process", nor any moment or occurrence computed for each possible (multiple "past/s", "present/s" or "future/s" ) UF's for each of the almost eight Billion Individual Human Consciousness! It is all directed and being computed by this singular higher-ordered UCR based on the Moral Choice/s taken by each of these Billions of Individual Human Consciousness based on that singular higher-ordered UCR's striving towards the Ultimate "Geula Perfected State"! In that sense, both the ongoing continuous UCR's computation, production, "dissolution", sustenance and evolution of each exhaustive spatial pixel comprising the entire physical universe for each consecutive UF's frame/s – may be considered as a "miracle" – i.e., in the sense that it cannot be conceived within our limited "Human Consciousness" and "Human Intelligence": how can this singular "Universal Consciousness Reality" take into consideration and "compute" the (apparently) "infinite complexity" of almost eight Billion Individual Human Beings – with each one of them making a "Moral-Choice" at any point in time which involves and affects multiple other Human Beings, and which as to take into consideration also all of the "past" "present" and multiple possible "future/s Universal Frames – needed to rectify and "balance" any "immoral choice/s" of each Individual Human Consciousness in each of these past/present/future/s Universal Frames... Moreover, as described in previous articles delineating this New "G-d's Physics" Paradigm, based on the

"Inseparability Principle" pointing at the "inseparability" of each such "Individual Human Consciousness from the singularity of the Universal Consciousness Reality; and moreover based on the postulated possibility of Human Beings to reach an "expanded Individual Human Consciousness" State in which the apparently "Individual Human Consciousness" functions in "complete identification" (and "Conscious inseparability") with the singular Universal Consciousness Reality – therefore in such an "expanded Individual Human Consciousness; therefore, in particular in such an "Expanded" Individual Human Consciousness State there exists the real possibility of such and "Expanded" Individual Human Consciousness to "alter" the standard "laws of nature" – i.e., which were seen to represent no more than a manifestation of the singular Universal Consciousness Reality's continuous production- dissolution- and re-production of the apparently "transient" and "phenomenal" physical universe, so that indeed "miracle" can (and do) happen!
